

# Anime Park 2020 Vendors/Artists Agreement

Thank you for participating in this year's convention! We are so happy and honored to have you here with us and to experience the joy of anime! Although we want our convention to be enjoyed by all, we ask that you abide by these guidelines listed below.

Tables for artists are **\$10** each (**2.5'x5'**), and **\$25** each for dealers/vendors (**2.5'x10'**). For vendors/artists only, additional tables cost \$10 each. Tables dimensions are 2.5'x5' and constitute as 1 space each.

- I. **Please complete and submit a 2019 vendors application found on Anime Park's website under "Dealers, Artists, Panels and Guests".**

- II. **We ask that NO outside food and beverage be brought on campus, and/or sold at your booth for health reasons.**
- III. **Accommodations such as table/booth placement, power outlets or extra space must be addressed in your application and are limited in availability. Those with addressed disabilities will be given priority.**
- IV. **Anime Park is not responsible for any lost, stolen, or damaged items.**
- V. **Member(s) of Anime Park's Con-Ops will be available in the vendor's room / Artist alley to assist you in setting up and taking down your booth. If you have any questions regarding setup, please consult Con-Ops.**
- VI. **We ask that vendors and artists do NOT sell 18+ material and that having said material hidden at your booth is unacceptable. If Con-Ops finds your material unsuitable, you will be asked to completely remove it from your booth.**
- VII. **Haggling of any sorts is not permitted at Anime Park. As a vendor / artist, you have the right to not sell to a haggling guest.**

## **Payment:**

Payment will be completed through PayPal. Once you have successfully completed the online Google Form, and your application has been accepted, you will receive a customized PayPal invoice, indicating your cost. Payment is expected by **May 9<sup>th</sup>, 2020.** Vendors and artists who do not pay by the above date will lose their spot. ## **Refunds:**

**Violations:**

During the day of the convention, any breaches in the contract, and/or you are a threat to the rest of the convention's safety in any other way, then you will be asked to leave the convention. No refund for your tables will be provided, and you will be barred from any future Anime Park conventions indefinitely.
